The Event Organisers may refuse any entrant in accordance with the IHRA Rules & Regulations.

All entrants must hold a current un-suspended driver's license.

Provisional license holders are permitted under the conditions outlined in the entrant terms and conditions.

Learner drivers are not permitted.

The driver of the entrant vehicle MUST be the registered entrant for that vehicle, subsequent drivers are not permitted.

Refer to Appendix A for the full entrant terms and conditions.

4. ALCOHOL, DRUGS AND OTHER SUBSTANCES

Consumption of alcohol in the pits, unlicensed areas or any section of the competition area under the control of the Officials is forbidden. Accordingly, all Entrants will be tested for the presence of alcohol by an Official before competing. Any driver/crew returning a measurable meeting above 0.000 will be excluded from the Event.

Entrants may be tested for the presence of drugs (or other banned substances) and subject to a penalty (ies) for a breach.

The above is in accordance with the <u>IHRA Australia Burnout Competition Regulations & Safety</u> Manual.

5. REMOTELY PILOTED AIRCRAFT (RPA)

An RPA (drone) can be used at an IHRA permitted event, provided the RPA is operated within the guidelines outlined below:

- The RPA, RPA operator, and usage is approved by the Event Organisers.
- The RPA operator or controller is certified by Australian Civil Aviation Safety Authority (CASA).
- The operator carries their own Public Liability Insurance (PLI).

6. EVENT REGULATIONS

This Event is a multi-discipline event held under the guidance and regulations as set down by IHRA Australia under the respective IHRA Australia Competition Regulations & Safety Manual, the Event Terms & Conditions of Entry (Appendix A), and these Event Supplementary Regulations.

This Event is also held in accordance with these Supplementary Regulations and any further regulations or Bulletins which may be issued, in reference to IHRA Australia.

Other activities may be conducted at the event that may not be under the conditions and Permit of Motorsport Australia and will be solely the responsibility of the promoter.

This event may be abandoned, postponed, or cancelled in accordance with IHRA Australia. This event shall only be abandoned or cancelled in the case of Force Majeure under a decision of the IHRA Race Meeting Director.

Any Protest or Appeal of any result or decision must be in accordance with IHRA Australia Protest Policy.

7. PASSENGER POLICY

IHRA Passenger Policy

Passengers are permitted for eligible driving events only, at the officials' discretion.

Driving events eligible for passengers are:

Competition Burnouts

o (3 Passenger, only if there is a seat per passenger available, 16 years and over)

Powerskid

o 1 Passenger, 16 years and over



Roll Racing

o 1 Passenger, 16 years and over

Cruise Route

- o passenger as per available seats and seatbelts within the vehicle, all ages
- passengers during cruise route activities are not required to complete the passenger waiver form

Skid Row

o passengers must be 12 years or older

Drag Racing

- Passengers are NOT permitted during competition
- Passengers during non-competition permitted as per Springmount Track Regulations

All passengers are required to sign the IHRA Passenger Ride Entry Form and once the form has been signed and witnessed by an official, the passenger will be provided with a passenger wristband. This wristband must remain fitted for the duration of the Event, or for the duration of their participation as a passenger.

Passengers during cruise route activities not required to complete the passenger waiver form.

Passengers who are under the age of 18, require a parent or legal guardian to authorise the IHRA Passenger Ride Entry Form.

If no passenger wristband is fitted, officials will request the passenger to complete a IHRA Passenger Ride Entry Form prior to their participation. Regardless, if they have previously signed a form. No signature, no wristband, no participation.

The passenger wristband will be supplementary to any other event wristband.

Entrant/drivers are not required to complete the IHRA Passenger Ride Entry Form, as all entrants/drivers have signed a waiver form during the event registration process.

Passengers must wear the mandatory PPE, for the eligible driving event, as outlined within these Supplementary Regulations.

8. FUEL

8.1. Storage

Entrants participating in competitions are permitted to store fuel within their designated pit.



Fuel must be stored in approved portable containers, in well-ventilated areas out of direct sunlight.

8.2. Refuelling

Refuelling is permitted in the designated pit area. Entrants must have an extinguisher and spotter when refuelling.

The driver and any passenger must be out of the vehicle during any refuelling.

Smoking is prohibited in the refuelling areas.

Children are not permitted in the refuelling area.

9. SCRUTINEERING

Scrutineering is held in the designated scrutineering shed, during the below days and times.

Entrants who are competing / participating in burnout competitions, Powerskids and roll racing are required to undergo scrutineering, in line with the IHRA Australia Rules and Regulations, including random audits. Drivers will be required to complete the BURNOUT CAD form and sign on at the track. Driver and passenger PPE will be checked at time of sign on.

Drag Racing entrants are required to undergo scrutineering in line with the Springmount Raceway and IHRA Australia requirements.

Entrants with road-registered vehicles that are either unmodified or have approved modifications and are not participating in driving events that require scrutineering, do not need to go through the full scrutineering process.

Instead, they will need to complete a 'Self Declaration' confirming that their vehicle is road-registered, complies with the National Vehicle Safety Standards (Australian Design Rules / ADRs), and is either unmodified or modified within the guidelines of the National Code of Practice for Light Vehicle Construction and Modification (VSB14).

10.COMPETITION VEHICLES & LICENCING

All Entrants and vehicles competing in driving events must comply with the following:

- Event Supplementary Regulations
- Full scrutineering



• hold and or obtain an IHRA competition licence

The driving events include:

- Burnouts
- Go-Woah
- Powerskids
- Roll Racing
- Drag Racing
- Northern Nats Champion

IHRA Australia competitor licence cost is included in your entry fee. Each entrant must agree to the terms of IHRA Australia to be issued a licence, completed at time of entrant application.

Entrants who hold an existing IHRA Australia competitor licence applicable to the event will not be required to obtain a competition licence at the event. Entrants holding such a licence must contact the Northern Nats team to advise of the licence held - via email info@northernnats.com.au

For all driving events, the driver must be the registered Entrant with the vehicle. Subsequent drivers are not permitted.

11. COMPETITION EVENTS

11.1. Burnouts

The burnout competitions will be conducted in accordance with the <u>IHRA Australia Burnout Competition Regulations & Safety Manual</u> and these Event Supplementary Regulations.

Passengers are permitted within competition vehicles – Refer to Section 7 – Passenger Policy, for conditions.

Driver and Passenger PPE Requirements

For all **NON-METHANOL** fuelled vehicles:

- Long sleeves and long pants (non-flammable)
- Helmet approved automotive helmet meeting AS 1698 or other IHRA Australiarecognised standard
- Enclosed shoes

For all **METHANOL** fuelled vehicles:



- **Fire Suit:** Must meet or exceed SFI 3.2A/5 or FIA 8856-2000 standards. Fire suits must be supplied by the Entrant they will not be provided or available for hire from Event Organisers.
- Helmet approved automotive helmet meeting AS 1698 or other IHRA Australiarecognised standard
- Enclosed shoes

All drivers and their passengers must comply with the following:

- Use a seatbelt or harnesses
- Purchase the applicable competition fee to participate in burnouts
- Attend (or where appliable complete) the compulsory drivers briefing
- Not be under the influence of alcohol. Random Breath Testing will be conducted on drivers and passengers
- Follow direction from Event Organisers and Officials if in breach

Vehicle Safety

- A tailshaft loop is not required but is recommended
- A scatter shield is not required but is recommended
- Non-functioning rear brakes are permitted during burnout competitions only
- Steel rims only, alloy rims are not permitted during competition
- Steel valve caps are not permitted during competition
- No loose items are to be inside the vehicle or boot area
- Selfie sticks are not permitted during competition
- Where a go pro or similar is used, it must be securely fixed with an appropriate mount.
- Mechanical works (including wheel changes) cannot be undertaken in the staging area without official's approval
- Burnout vehicles are not permitted to return to the pits on rims. Spares are to be located on the burnout staging paddock.
- Vehicles must have a working battery isolation switch (external mount not required).

The following will apply the Event:

The Driver and passenger must remain restrained in the automobile at all times whilst the automobile is in motion and until such time as the burnout has ceased or red flagged. Waving of arm/s from the window of the automobile is permitted during the conduct of the burnout.

Competition Format

Each category will have three (3) burnouts per entrant:



- Development Category 3 burnouts
- Open Category 3 burnouts
- Pro Category 3 burnouts

The highest combined score across all three burnouts will determine the winner in each category.

Competition Schedule

Refer to the Event Program for the detailed competition schedule.

Judging

Refer to the Northern Nats Burnout Rules.

The Burnout Judged (Judges of Face) are:

- Kevin Peisley Chief Judge Development, Open & Pro Category (remote)
- Matt Rowland Judge Development, Open & Pro Category (remote)

The judge's decision shall be applied as a 'Judge of Fact' and are considered final. No protest may be made regarding the decision of the judges.

Awards

Refer to the Entrant Participation Guide for Awards.

11.2. Powerskids

The Powerskid Competition will be conducted in accordance with the IHRA Australia Rules & Regulations and these Event Supplementary Regulations.

Passengers are permitted within competition vehicles – Refer to Section 7 – Passenger Policy, for conditions.

Driver and Passenger PPE Requirements

For all **NON-METHANOL** fuelled vehicles:

- Long sleeves and long pants (non-flammable)
- Helmet approved automotive helmet meeting AS 1698 or other IHRA Australiarecognised standard
- Enclosed shoes

For all **METHANOL** fuelled vehicles:



- **Fire Suit:** Must meet or exceed SFI 3.2A/5 or FIA 8856-2000 standards. Fire suits must be supplied by the Entrant they will not be provided or available for hire from Event Organisers.
- Helmet approved automotive helmet meeting AS 1698 or other IHRA Australiarecognised standard
- Enclosed shoes

All drivers and their passengers must comply with the following:

- Use a seatbelt or harnesses
- Not be under the influence of alcohol. Random Breath Testing will be conducted on drivers and passengers
- Follow direction from Event Organisers and Officials if in breach

Competition Schedule

Judging

Powerskids will be judged on distance and volume of smoke.

11.3. Drag Racing

The drag racing competition will be conducted in line with the Springmount Raceway Track Championship.

Driver PPE Requirements required as outlined within the IHRA Protective Clothing Matrix, for their respective race category – <u>refer to the IHRA website</u>.

Competition Schedule

Refer to the Event Program for the detailed competition schedule.

Judging & Awards

Refer to the Entrant Participation Guide for Judging Categories & Awards.

11.4. Go-Woah

The Go-Woah competition will be conducted in accordance with the IHRA Australia Rules & Regulations and these Event Supplementary Regulations.

Driver and Passenger Requirements

All drivers and their passengers must wear the following apparel:



Enclosed footwear

All drivers and their passengers must comply with the following:

- Use a seatbelt or harnesses
- Not be under the influence of alcohol. Random Breath Testing will be conducted on drivers and passengers
- Follow direction from Event Organisers and Officials if in breach

Competition Schedule

Refer to the Event Program for the detailed competition schedule.

Judging & Awards

Entrants can complete each course four (4) times and the (lowest time) highest scored run will be used for qualifying.

Refer to the Entrant Participation Guide for Judging Categories & Awards.

12.NON-COMPETITION

12.1. Event Cruising

Passengers are permitted in entrant vehicles during cruising – refer to Section 7 for the Passenger Policy.

Driver and Passenger Requirements

All drivers and their passengers must comply with the following:

- Adhere to the road regulations and any direction issues by the Event Organiser or any other local authorities (i.e. Queensland Police)
- Ahere to the Cruise Route speed limit of 20km/h
- Use a seatbelt or harnesses (unless the vehicle was originally manufactured without them)
- Use an approved child restraint, if applicable
- No burnouts or powerskid's (outside of the designated skid row space)
- Not be under the influence of alcohol. Random Breath Testing will be conducted on drivers and passengers
- Follow direction from Event Organisers and Officials if in breach

Cruising Schedule

Refer to the Entrant Participation Guide and the Event Program for the detailed schedule.



12.2. Skid Row

Passengers are permitted in entrant vehicles during cruising – refer to Section 7 for the Passenger Policy.

The Skid Row Activity will be conducted in accordance with the IHRA Australia Burnout Competition Regulations & Safety Manual and these Event Supplementary Regulations.

Driver and Passenger Requirements

All drivers and their passengers must comply with the following:

- Use a seatbelt or harnesses
- Not be under the influence of alcohol. Random Breath Testing will be conducted on drivers and passengers
- Follow direction from Event Organisers and Officials if in breach

Vehicle Safety

- A tailshaft loop is not required but is recommended
- Vehicles must have a bonnet
- Vehicles registered as hot rods with no bonnet must have guards on any exposed components

Rules & Regulations

- No static burnouts permitted
- No loops permitted
- No popped tyres are permitted

When participating in the Skid Row Activity, drivers and their vehicle must comply with the following:

- 1. Drive in a straight line
- 2. Move with constant forward motion
- 3. Travel for a maximum distant of 40m
- 4. Produce a modest amount of smoke (permitted but not mandatory)
- 5. Travel at a maximum speed limit of 20km/h
- 6. Travel for a maximum time of 20 seconds
- 7. Complete the activity with no tyre delamination
- 8. Must stop upon completion of activity and wait for approval to leave by officials

Flag Signals:

A green flag indicates commencement of the activity area. Drivers must only enter the Skid Row Activity area when a green flag is provided.

A red flag indicates an immediate stop of activity to the driver and the passenger.



If a red flag is enacted for a fire, the driver of the vehicle must follow directions from the officials before restarting the vehicle.

If directed by officials, the vehicle will be pushed or towed out of the activity zone.

Skid Row Schedule

Refer to the Entrant Participation Guide and the Event Program for the detailed Skid Row Schedule.

Entrants can complete skid row as many times as available within the schedule.

12.3. Roll Racing

Passengers are permitted in entrant vehicles during roll racing – refer to Section 7 for the Passenger Policy.

Driver and Passenger Requirements

All drivers and their passengers must comply with the following:

- Adhere to the road regulations and any direction issues by the Event Organiser or any other local authorities (i.e. Queensland Police)
- Use a seatbelt or harnesses
- No burnouts or powerskid's
- Not be under the influence of alcohol. Random Breath Testing will be conducted on drivers and passengers
- Follow direction from Event Organisers and Officials if in breach

Driver and Passenger PPE Requirements

For all **NON-METHANOL** fuelled vehicles:

- Long sleeves and long pants (non-flammable)
- Helmet approved automotive helmet meeting AS 1698 or other IHRA Australiarecognised standard
- Enclosed shoes

For all **METHANOL** fuelled vehicles:

• **Fire Suit:** Must meet or exceed SFI 3.2A/5 or FIA 8856-2000 standards. Fire suits must be supplied by the Entrant — they will not be provided or available for hire from Event Organisers.



- Helmet approved automotive helmet meeting AS 1698 or other IHRA Australiarecognised standard
- Enclosed shoes

Roll Racing Schedule

Driver Briefing

All Roll Racing entrants must attend the daily driver briefing held at **8:30am** at the **scrutineering shed**. Attendance is **mandatory**. This session will cover the operational procedures, safety expectations, and race conduct. Failure to attend will result in exclusion from participation.

Start Procedure

- A portable start tree will be set up at the **330-foot mark** by the designated official.
- The tree is manually operated from trackside to initiate the green light signal.
- A start official will be stationed in the start area to wave forward and pair vehicles for each run.

Rolling Start Format

- Vehicles will accelerate to a **rolling speed of 50–60km/h** prior to reaching the 330-foot start mark.
- The **tower-side lane** vehicle leads and sets the rolling pace.
- The crowd-side lane vehicle must match the lead vehicle's speed and positioning.
- If the vehicles are not adequately aligned at the start line, the green light will not be activated and the run will be aborted.

Race Distance

• The race starts at the **330-foot mark** and finishes at the **1320-foot mark**, totalling a race distance of **990 feet**.

Winner Determination

• A finish line spotter will visually determine the winner and communicate the result to the control tower via radio.

Refer to the Entrant Participation Guide and the Event Program for the detailed schedule.

12.4. Northern Nats Champion

Northern Nats Champion Contenders are required to compete in the following driving events, including the conditions outlined in these Event Supplementary Regulations;

- Drags
- Go-Woah
- Show N Shine

13.1. Appendix A – Entrant Terms and Conditions

ENTRANT TERMS AND CONDITIONS

1. DEFINITIONS

1.1. 'We' means the Event Organiser [Out There Productions Major Events Pty Ltd Pty Ltd]. 'The Event' means the [NorthernNats 09] Event. 'You' means the customer. 'Entrant' means you, the customer. 'Entrant Terms and Conditions' means this document.

2. COMPLIANCE WITH ENTRANT TERMS AND CONDITIONS, LOCAL LAWS AND CONDITIONS OF ENTRY

- 2.1. By purchasing an Entrant ticket you are agreeing to comply with all Entrant Terms and Conditions.
- 2.2. By participating in the Event you agree to not engage in any activities that may violate local laws or endanger the reputation of the Event.
- By participating in the Event, you agree to comply with the Event Conditions of Entry and Prohibited Items.

3. SANCTIONING BODY

- 3.1. The Event is a multi-discipline and club status Event sanctioned by IHRA.
- 3.2. The Event operates under the Sanctioning Body Standing Regulations, Event Supplementary Regulations and these Entrant Terms and Conditions.
- 3.3. By accepting these Entrant Terms and Conditions you are agreeing to comply with all applicable Event Regulations.

4. ACKNOWLEDGEMENT OF RISK

- 4.1. Motorsport events are dangerous and may result in injury or death to the person or damage to property. As an essential condition of entry, each Entrant/ participant/ official and spectator acknowledges, prior to entering any Event he/she has made him/herself fully aware of the danger as a participant or spectator and or property owner and has accepted all risks. The Entrant, for him/herself, and as agent for any accompanying child, releases, and discharges absolutely the Promoter, the Event Sponsors, and the Event, their employees, contractors, representatives, agents and officials from any liability arising from any circumstance whatsoever, to the full limit as allowed under Australian Consumer Law
- 4.2. Further information on the Sanctioning Body Risk Statements can be found here.
- 4.3. By accepting these Entrant Terms and Conditions you are agreeing that you have made yourself aware of the relevant Risk Statement and associated risks.
- 4.4. Dependent on the Sanctioning body, there may be a requirement to sign a further risk statement document at the event.

5. TICKETING & REFUNDS

- 5.1. All Entrant tickets purchased are non-refundable and non-transferrable. Credit transfers for future Events or alternate tickets will not be issued.
- 5.2. We are not involved in the on-selling of Entrant tickets.
- 5.3. All Entrants are entitled to purchase a maximum of five (5) Entrant tickets for the event.
- 5.4. Entrant Competition Fees are non-refundable and non-transferrable.

6. EVENT CANCELLATION

- 6.1. We reserve the right to postpone or cancel the Event for any reason.
- 6.2. In the occurrence of the cancellation in advance of the Event, we will provide a full refund (excluding credit card processing fee).



- 6.3. In the occurrence of a cancellation or postponement due to Government order, We reserve the right to reschedule the Event and offer an exchange to the rescheduled Event.
- 6.4. In the occurrence of a reschedule, Entrants will be contacted directly with options to receive an exchange or refund.

7. LICENCE REQUIREMENTS

- 7.1. Entrants must hold a current, un-restricted, unsuspended drivers' licence.
- 7.2. Learner drivers are not permitted.
- 7.3. Entrants holding a provisional licence must comply with the license conditions of the state of issue.
- 7.4. Entrants with a provisional license which does not permit them to drive their Entrant vehicle on normal roads are permitted to enter the Event but are restricted to participating in competitions only.
- 7.5. Entrants with a provisional license which does not permit them to drive their Entrant vehicle on normal roads must have a dual Entrant with a full, unrestricted license. The dual Entrant with a full unrestricted license is responsible for driving the vehicle to and from the competition locations. The dual Entrant must be entered into the Event with the same vehicle as the provisional licence Entrant.
- 7.6. The driver of the Entrant vehicle must be the registered Entrant for that vehicle. No other person is permitted to drive the vehicle at the Event. Disciplinary action applies.

8. VEHICLE APPROVAL

- 8.1. Acceptance of the Entrant vehicle for the Event is at the absolute discretion of the Event Organiser.
- 8.2. Vehicle entries will only be considered if all criteria are met, and your application is fully completed including payment in full.
- 8.3. We reserve the right to decline any entry during the application process without providing a reason.
- 8.4. In the event of an entry being declined during the application process a refund will be issued.
- 8.5. If your vehicle fails Scrutineering at the Event, it will not be permitted to participate in the Event. In this occurrence you will be considered a Non-Participating Entrant and your ticket will be transferred to a spectator ticket.

9. ENTRANT REQUIREMENTS

- 9.1. To be considered an Entrant at the Event, you must bring your vehicle to the Event and successfully pass scrutineering.
- 9.2. If you do not bring your vehicle to the Event, you will be considered a Non-Participating Entrant.
- 9.3. If you have multiple vehicles entered on the same name, only one (1) wristband will be issued to you.

10. NON-PARTICIPATING ENTRANT

- 10.1. If you are unable to bring your vehicle to the Event (Non-Participating Entrant) or your vehicle fails Scrutineering, your ticket will be transferred to a spectator ticket and you will be able to collect your Entrant Pack at the Event. Entrant Packs do not include Entrant Stickers. Additional conditions may apply for collecting Entrant packs at the Event.
- 10.2. By not bringing your vehicle to the Event you are not eligible for a Buddy Pass (where Buddy Passes are an inclusion with the Entrant Pass only).



10.3. By not bringing your vehicle to the Event you are not eligible for an Entrant Competition Support Vehicle Pass.

11. VEHICLE CHANGES

- 11.1. Change of vehicles are permitted provided the new vehicle meets the minimum requirements as outlined in the 'Vehicle Entry Guide' document.
- 11.2. Vehicle swaps will be permitted up to 2 weeks prior to the first day of Scrutineering at the Event.
- 11.3. Vehicle swap will incur an additional fee of \$50 plus any credit card and booking fees per change.

12. DRIVER CHANGES

- 12.1. Change of driver will be permitted up to 4 weeks prior to the first day of Scrutineering at the Event.
- 12.2. Change of driver will incur an additional fee of \$100 plus any credit card and booking fees, upon each request to change.
- 12.3. Change of driver includes the transfer of all purchases associated with the original entry, including any additional season passes, merchandise and competition fees.
- 12.4. Change of driver does not include the transfer of any camping site or camping passes purchased under the original entry.
- 12.5. Change of driver is subject to approval.

13. EVENT CODE OF CONDUCT

- 13.1. Zero tolerance to anti-social behaviour, physical or verbal aggression, indecent, obscene or threatening language, sexually harassing behaviour, offensive or indecent behaviour.
- 13.2. Failure to comply with a reasonable direction from event management or responsible authorities.
- 13.3. Any anti-social behaviour will result in removal from the event, and may see exclusion from future events or disciplinary action by the appropriate authorities.

14. ENTRANT COMMUNITY CODE OF CONDUCT

We believe in fostering a positive and respectful community that reflects the spirit of our Event. By entering the Event, you agree to abide by this Entrant Community Code of Conduct and help us create an enjoyable and safe environment for everyone. 14.1. Respectful Communication

- Treat others with respect and courtesy in all interactions related to the Event.
- Any offensive or derogatory language, behaviour, emails, phone calls and social media comments
 and posts will not be tolerated and will result in your Entrant privileges being removed and tickets
 cancelled.

14.2. Positive Promotion

- Feel free to share and post your positive experiences from the Event. Spread the enthusiasm in a friendly and constructive manner.
- Any online behaviour that violates this Entrant Community Code of Conduct including posting
 images or videos of anti-social behaviour including dangerous driving will not be tolerated and will
 be dealt with appropriately.

15. ENTRANT BEHAVIOUR



By participating in the Event, you agree to conduct yourself in accordance with the following Entrant Behaviour. As an Entrant, you are an essential part of creating a safe, enjoyable, and memorable experience for everyone involved.

15.1. Show Respect & Respect the Show

- Treat all participants, attendees, staff, security and volunteers with respect and courtesy.
- Always conduct yourself in a responsible and well-behaved manner.
- You are responsible for the behaviour of the passengers in your Entrant vehicle.
- Any anti-social or dangerous behaviour conducted by passengers within your Entrant vehicle will
 be subject to Event disciplinary measures and may be subject to Sanctioning Body disciplinary
 action and Police action.

15.2. Safety First

- Prioritize safety in all your activities during the Event.
- Follow all safety guidelines and instructions provided by the Event Organisers and venue staff.

15.3. Responsible Driving

- While driving your vehicle within the Event premises or on public roads surrounding the venue, always adhere to traffic rules and speed limits.
- Do not conduct any form of reckless driving, or any actions that may endanger yourself, other participants, or bystanders.
- As an Entrant you are representing the Event. Any form of reckless or dangerous driving outside
 of the Event venue will be dealt with in the same manner as if it was inside the Event including
 Sanctioning Body disciplinary action and Police involvement.
- Any Entrant displaying behaviour that violates normal road rules will be subject to Event disciplinary action and may be subject to Police and Sanctioning body disciplinary action.

15.4. No Burnouts

- Burnouts are only permitted to be performed on the burnout pad during competition.
- Burnouts are <u>PROHIBITED</u> in all other areas at all times.
- Any Entrant conducting burnouts in any area other than the burnout pad during competition will
 be subject to Event disciplinary action including eviction from the Event and may be subject to
 Police and Sanctioning body disciplinary action.

15.5. Alcohol and Substance Use

- If you choose to consume alcohol, do so responsibly and in accordance with the law and your licence requirements. Excessive drinking that leads to disruptive behaviour will not be tolerated.
- Entrants competing in events must return a negative blood alcohol reading to be permitted to compete. A NEGATIVE READING means a reading that is less than or equal to "0.010" as displayed on a breathalyser and as outlined in the appointed sanctioning body Alcohol Policy.
- Breath testing is conducted at the Event.
- The use, possession, or distribution of illegal substances is strictly prohibited and will result in immediate removal from the Event and Police action.

15.6. Cooperation with Officials

- Cooperate with Event Organisers, security personnel, and law enforcement officers at all times.
- Follow their instructions promptly and without argument.

15.7. Accountability

Take responsibility for your actions during the Event and accept the consequences of any
misconduct or violations.



 Failure to comply with this Entrant Behaviour may result in consequences, including warnings, expulsion from the Event, banning from future Events, or, in severe cases, legal action.

16. VEHICLE SEARCHES

- 16.1. By participating in the Event, you are agreeing to undergo a vehicle search each time you enter the venue and any other time at the discretion of Event Organisers.
- 16.2. The purpose of these searches is to prevent potential hazards, illegal activities, and ensure compliance with Event rules and regulations.
- 16.3. Vehicles will be searched for any prohibited items.
- 16.4. Any prohibited items will be confiscated and will not be returned.
- 16.5. Entrants are expected to comply with instructions given by security personnel during the search and are expected to treat the security personnel with respect during the search.

17. LIABILITY

- 17.1. To the fullest extent permitted by law, we do not accept liability of any nature for the acts, omissions, or default of those providing services in connection with the Event or any liability for any illness, injury, damage, loss, delay or additional expenses which are incurred at or in association with this Event. Where legislation implies any condition or warranty which cannot be excluded or modified, that condition or warranty will be deemed to be included in this agreement. However, our liability for any breach of such condition or warranty will be limited, at our option, to the resupply of the services or the cost of having the services supplied again. In no Event will we be liable for any indirect, consequential, exemplary, or special damages.
- 17.2. You acknowledge that neither We nor the venue will be responsible for any loss or damage to the property (including personal property such as bags, money, or other personal items) brought to or purchased at the Event by you or your invitees.
- 17.3. You will be liable for any loss or damage caused at the Event by you or your invitees.

18. RIGHT OF ADMISSION

18.1. The right of admission to the Event is reserved and is subject to the Event Organiser and the Event Terms and Conditions.

19. PRIVACY POLICY

- 19.1. Pursuant to your booking, we may need to collect and keep personal information about you including your name, address, credit card or payment details, telephone number and the names of all ticket allocations. Your name, address and contact details will be shared with the Sanctioning Body responsible for the Event. We will collect and store your information, and if required by law, disclose information in accordance with the Privacy Act 1988.
- 19.2. By entering (event), you give permission for the organisers to discuss and make alterations to your entry with the listed Entrant, or your emergency contact.
 We (event) are not able to discuss your application form with anyone else without prior written approval from the listed Entrant.

20. IMAGE USE

20.1. As a condition of entry, each Entrant or agent for any accompanying adult and as parent or guardian for any accompanying child, grants to the Event Organiser the exclusive right to photograph or film or portray the Entrant, any accompanying adult or child and the Entrant's



vehicle to use such photograph, film, portrayal without names or credits as the Event Organiser may in their absolute discretion think fit.
